Description

The four story Castle Buildings, provide modern office accommodation, which was rebuilt behind an original stone façade in the early 2000's. The 3rd floor office space and the last remaining available suite provides a mix of open plan and cellular office accommodation completed to a modern standard in the heart of Bury Town Centre. The office benefits from a shared ground floor entrance area with lift access direct into the office accommodation, recently installed LED lighting, male, female W.C.s a small kitchen area, perimeter trunking, gas central heating and air conditioning.

Location

The Castle buildings occupies a prominent position fronting Market Place, opposite the Church of St Mary and close to th Town Centre amenities as it is a short walk to both Mill Gate and The Rock Shopping Centres, in Bury Town Centre.

The property has also great transport links as it is situated close to the A58 which links Bury with Bolton and Rochdale, the A56 which provides a direct route to Manchester city centre as well as the M66 motorway which ultimately leads to all other major motorway networks. Bury Interchange can also be accessed within a 5 minute walk from the subject property.
