Description

The property comprises a ground floor end of terrace mixeduse retail premises located on St James Street, Farnworth. It occupies a prominent position within a well-established retail parade, benefiting from excellent visibility.

Internally, the unit offers a well-presented open-plan sales area, together with a rear storage room and W.C. The accommodation has recently been refurbished throughout and ready for an occupiers fit out. Additional features include double glazing to the front along with secure electric roller shutters.

The premises are suitable for a range of potential uses, subject to obtaining the necessary consents.

Location

Situated on St James Street, Farnworth, the property occupies a convenient position less than a mile from Farnworth Town Centre, within a well-established area comprising local shops, schools, and residential housing. It benefits from excellent transport connections, with main bus routes nearby and Farnworth and Moses Gate railway stations both approximately one mile away. The location also provides easy regional access via Junction 4 of the M61 and the A666, linking directly to the M60 motorway network.
